RESOLUTION NO. R-15-1068

A RESOLUTION OF THE CITY OF MAPLE VALLEY, WASHINGTON, AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERLOCAL AGREEMENT WITH THE CITIES OF COVINGTON, BLACK DIAMOND AND MAPLE VALLEY FOR PLANS EXAMINATION AND BUILDING INSPECTION SERVICES

WHEREAS, the cities of Covington, Black Diamond and Maple Valley, hereinafter “Parties”, are “public agencies” as defined by Chapter 39.34 RCW, and through the provisions of that Chapter are authorized by state law to enter into interlocal agreements on the basis of mutual advantage and thereby to provide services and facilities in the manner and pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors influencing the needs of local communities; and

WHEREAS, RCW 39.34.030 authorizes an agreement for joint or cooperative action by a public agency upon appropriate legislative action by the governing body of each agency prior to entry into such agreement; and

WHEREAS, the Parties’ Community Development Departments have similar operational needs and can provide savings to taxpayers through contracting for shared services; and

WHEREAS, each Party can realize certain economies from sharing resources; and

WHEREAS, the City of Maple Valley adopted Resolution R-14-1014 on December 8, 2014, authorizing the City Manager to execute an Interlocal Agreement with the Cities of Covington and Black Diamond for Plans Examination and Building Inspection Services; and

WHEREAS, the Interlocal Agreement for Plans Examination and Building Inspection Services is set to expire on December 31, 2015; and

WHEREAS, the parties desire to continue the Interlocal Agreement for plans examination and building inspection services;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, DO RESOLVE AS FOLLOWS:

Section 1. Authorization. The City Manager is hereby authorized to execute an Interlocal Agreement with the Cities of Covington and Black Diamond for plans examination and building inspection services in substantially the same form as attached. A copy of the Interlocal Agreement has been filed with the City Clerk and identified with Clerk's Receiving No. _____.
