**RESOLUTION NO. R-15-1051**

**A RESOLUTION OF THE CITY OF MAPLE VALLEY, WASHINGTON, AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF MAPLE VALLEY AND WASHINGTON STATE DEPARTMENT OF ECOLOGY FOR PROVISION OF 2015 THROUGH JUNE 30, 2017 COORDINATED PREVENTION GRANT AGREEMENT.**

WHEREAS, Washington State Department of Ecology (Ecology) Coordinated Prevention Grant funds are allocated to agencies based on population as reported by Washington State Office of Financial Management; and

WHEREAS, Maple Valley staff applied for and was awarded the 2015-2017 Coordinated Prevention Grant on behalf of the cities of Black Diamond, Covington, and Maple Valley; and

WHEREAS, Maple Valley acts as lead agent for the cities of Black Diamond and Covington pursuant to the Joint Public Works Operations and Cooperative Purchasing Interlocal agreement C-11-841 as approved by Maple Valley Council Resolution R-11-810 as amended by Resolution R-11-838; and

WHEREAS, the Coordinated Prevention Grant funds, combined with grant funds from other grantors, allow the three cities to offer special recycling collection events provide an avenue for the proper recycle items and divert items from entering the waste stream; and

WHEREAS, the special recycling collection program are consistent with the King County Solid Waste Comprehensive Plan and the Local Hazardous Waste Management Plan; and

WHEREAS, the cities desires to continue to offer these popular recycling collection events to the public;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, AS FOLLOWS:**

- A. The City Manager is authorized and directed to execute the finalized Washington State Department of Ecology Coordinated Prevention Grant Agreement subject to City Attorney review for provision of receiving grant funds on behalf of Black Diamond, Covington and Maple Valley for years 2015 through June 30, 2017.
