RESOLUTION NO. R-16-1073

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, AMENDING RESOLUTION R-06-495 STRIKING THE DECEMBER 31, 2016 SUNSET PROVISION OF THE LAKE WILDERNESS CITIZEN ADVISORY COMMITTEE.

WHEREAS, Lake Wilderness Management District No. 1, a Special Assessment District, was created April 25, 1998 by Council adoption of Ordinance O-98-57 for the purpose of funding the abatement of Eurasian Milfoil and the control of nuisance native weeds in Lake Wilderness; and

WHEREAS, attendant to the creation of the Special Assessment District, Council adopted Resolution No. R-02-220 creating the Lake Management District Advisory Committee and establishing the duties thereof; and

WHEREAS, both the Lake Management District No. 1 Special Assessment District and the Lake Management District Advisory Committee were to sunset concurrently on December 31, 2006; and

WHEREAS, Council adopted Resolution R-05-399 in May 2005 approving a ten-year budget forecast developed by the outbound Lake Management District Advisory Committee to continue to implement aquatic plant management and education and stewardship for Lake Wilderness for years 2007 through 2016; and

WHEREAS, the outbound Lake Management District Advisory Committee expressed interest in continued involvement of an advisory committee post sunset, and

WHEREAS, Council valued the dedication, commitment, and services provided by the Lake Management District Advisory Committee Council and in September 2006, Council adopted Resolution No. R-06-495, creating a new Lake Wilderness Citizen Advisory Committee establishing the duties thereof and setting the Committee sunset to coincide with the termination of the ten-year budget forecast on December 31, 2016; and

WHEREAS, on January 4, 2016 Council appointed three new members to serve two-year terms on the Lake Wilderness Citizen Advisory Committee from January 1, 2016 to December 31, 2017; and

WHEREAS, Council desires to amend Resolution R-06-495 striking the December 31, 2016 sunset provision of the Lake Wilderness Citizen Advisory Committee

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, DO RESOLVE AS FOLLOWS:

Section 1. Amendment. Section 4. of Resolution R-06-495 is hereby amended as follows:

~~Section 4. Sunset. The Advisory Committee shall terminate concurrently with the termination of the ten year budget, which is December 31, 2016.~~
