## **RESOLUTION NO. R-15-1069**

### **A RESOLUTION OF THE CITY OF MAPLE VALLEY, WASHINGTON, AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDED INTERLOCAL AGREEMENT WITH THE CITIES OF COVINGTON AND BLACK DIAMOND FOR JOINT PUBLIC WORKS OPERATIONS AND COOPERATIVE PURCHASING**

WHEREAS, the Parties are “public agencies” as defined by Chapter 39.34 RCW, and through the provisions of that Chapter are authorized by state law to enter into interlocal agreements on the basis of mutual advantage and thereby to provide services and facilities in the manner and pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors influencing the needs of local communities; and

WHEREAS, RCW 39.34.030 authorizes an agreement for joint or cooperative action by a public agency upon appropriate legislative action by the governing body of each agency prior to entry into such agreement; and

WHEREAS, the Parties’ Public Works and Parks Departments have similar operational needs and can provide savings to taxpayers through contracting for shared services; and

WHEREAS, each Party can realize certain economies from sharing resources and jointly contracting;

WHEREAS, the City of Maple Valley adopted Resolution R-11-810 on May 23, 2011 authorizing the City Manager to execute an Interlocal Agreement with the Cities of Covington and Black Diamond for joint public works operations and cooperative purchasing; and

WHEREAS, the City of Maple Valley adopted Resolution R-11-838 on December 12, 2011 authorizing the City Manager to execute an amended Interlocal Agreement with the Cities of Covington and Black Diamond for joint public works operations and cooperative purchasing; and

WHEREAS, the amended Interlocal Agreement will expire on December 31, 2015; and

WHEREAS, all three Parties agree it is in the best interest of the taxpayers to continue contracting for shared services and resources; and

WHEREAS, the parties desire to amend said Interlocal Agreement to extend the term of the agreement through December 31, 2020 and to amend Section 5.1 to reflect changes in the Joint Administrative Board Personnel;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY,  
WASHINGTON, DO RESOLVE AS FOLLOWS:**

Section 1. Authorization. The City Manager is hereby authorized to execute a second amendment to the existing Interlocal Agreement with the Cities of Covington and Black Diamond for Joint Public Works Operations and Purchasing.
