**RESOLUTION NO. R-16-1093**

**A RESOLUTION OF THE CITY OF MAPLE VALLEY, WASHINGTON, AWARDED THE BID FOR CONSTRUCTION SERVICES ON THE 2016 MISCELLANEOUS DRAINAGE IMPROVEMENTS & WATER QUALITY RETROFITS PROJECT (S-10) TO IRON CREEK CONSTRUCTION LLC AND AUTHORIZING THE CITY MANAGER TO EXECUTE A PUBLIC WORKS CONSTRUCTION CONTRACT WITH IRON CREEK CONSTRUCTION, LLC FOR SAID WORK.**

WHEREAS, the City Council of the City of Maple Valley desires to construct the improvements for the 2016 Miscellaneous Drainage Improvements & Water Quality Retrofits Project (S-10); and

WHEREAS, the City solicited Invitations to Bid from individual construction firms qualified to complete Project S-10; and

WHEREAS, the City received four proposals in response to the City's Invitation to Bid; and

WHEREAS, Iron Creek Construction LLC. was the lowest responsible bidder; and

WHEREAS, the City has reviewed bid documents submitted by Iron Creek Construction LLC., and has found them to be substantially complete; and

WHEREAS, the City is requesting that the City Council award the bid to Iron Creek Construction LLC and that the City Manager be granted the authority to execute a Public Works Contract with Iron Creek Construction LLC, to perform the construction services for S-10 2016 Miscellaneous Drainage Improvements & Water Quality Retrofits Project in the total bid amount of \$134, 381.64;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, DO RESOLVE AS FOLLOWS:**

Section 1. Bid Award. The City Council hereby awards the bid to complete Project S-10 to Iron Creek Construction LLC.

Section 2. Authorization. The City Manager is hereby authorized to execute a Public Works Contract with Iron Creek Construction, LLC to perform the Construction Services for the 2016 Miscellaneous Drainage Improvements & Water Quality Retrofits Project (S-10) in the total bid amount of \$134,381.64 plus a 10% contingency fund. A copy of the Public Works Contract has been filed with the City Clerk and identified with Clerk's Receiving No. \_\_\_\_\_.
