**RESOLUTION NO. R-16-1101**

**A RESOLUTION OF THE CITY OF MAPLE VALLEY, WASHINGTON, AWARDING THE BID FOR CONSTRUCTION SERVICES ON THE 240<sup>TH</sup> AVENUE SE & SE 276<sup>TH</sup> STREET ROADWAY IMPROVEMENTS (T-33A & T-33B) TO RIVERTON CONTRACTORS, INC. AND AUTHORIZING THE CITY MANAGER TO EXECUTE A PUBLIC WORKS CONSTRUCTION CONTRACT WITH RIVERTON CONTRACTORS, INC. FOR SAID WORK.**

WHEREAS, the City Council of the City of Maple Valley desires to construct the 240<sup>th</sup> Avenue SE & SE 276<sup>th</sup> Street Roadway Improvements Project (T-33a & T-33b); and

WHEREAS, the City solicited Invitations to Bid from individual construction firms qualified to complete Project T-33a & T-33b; and

WHEREAS, the City received six proposals in response to the City's Invitation to Bid; and

WHEREAS, Riverton Contractors, Inc. was the lowest responsible bidder; and

WHEREAS, the City has reviewed bid documents submitted by Riverton Contractors, Inc., and has found them to be substantially complete; and

WHEREAS, the City is requesting that the City Council award the bid to Riverton Contractors, Inc. and that the City Manager be granted the authority to execute a Public Works Contract with Riverton Contractors, Inc., to perform the construction services for T-33a & T-33b the 240<sup>th</sup> Avenue SE & SE 276<sup>th</sup> Street Roadway Improvements Project in the total bid amount of \$198,204.20;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, DO RESOLVE AS FOLLOWS:**

Section 1. Bid Award. The City Council hereby awards the bid to complete Project T-33a & T-33b to Riverton Contractors, Inc.

Section 2. Authorization. The City Manager is hereby authorized to execute a Public Works Contract with Riverton Contractors, Inc. to perform the Construction Services for the 240<sup>th</sup> Avenue SE & SE 276<sup>th</sup> Street Roadway Improvements Project (T-33a & T-33b) in the total bid amount of \$198,204.20 plus a 10% contingency fund. A copy of the Public Works Contract has been filed with the City Clerk and identified with Clerk's Receiving No. \_\_\_\_\_.
