RESOLUTION NO. R-16-1116

A RESOLUTION OF THE CITY OF MAPLE VALLEY, WASHINGTON, AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENT NO. 1 TO THE EXISTING CONTRACT WITH MEAD & HUNT INC., FOR ADDITIONAL DESIGN ENGINEERING SERVICES ON WITTE ROAD SE, PHASE 4 (BETWEEN SE 249TH AND SE 256TH STREET) ROADWAY IMPROVEMENTS PROJECT T-28B

WHEREAS, the City Council of the City of Maple Valley desires to construct the improvements for Project T-28B (Witte Road – Phase 4– from SE 249th to SE 256th Roadway Improvements); and

WHEREAS, the City, by means of a selection and interview process of individual engineering consultant firms qualified to perform design engineering services for Project T-28B, selected Mead & Hunt, Inc. on the basis of qualifications; and

WHEREAS, the City Council authorized the City Manager to execute a contract with Mead & Hunt, Inc. as is reflected in Resolution 15-1067; and

WHEREAS, in May 2016, the City Council concurred to expand the scope of Mead & Hunt’s design services to include utility undergrounding; and

WHEREAS, in order to complete these expanded design services for Project T-28B, the original contract must be amended to accommodate an expanded scope of work, an increased contract price and an extended duration; and

WHEREAS, the City has negotiated an amended scope of services and budget with Mead & Hunt Inc. increasing the original contract amount by \$19,081 to \$354,604.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, DO RESOLVE AS FOLLOWS:

Section 1. Authorization. The City Manager is hereby authorized to execute Amendment No. 1 to the existing contract with Mead & Hunt, Inc. (Contract No.C-15-1251), expanding the original scope of work for Project T-28B (Witte Road – Phase 4 – from SE 249th to SE 256th Roadway Improvements), increasing the contract price by \$19,081 to \$354,604, and extending the duration to December 31, 2017. A copy of the agreement has been filed with the City Clerk and identified with Clerk's Receiving No. _____.
