**A RESOLUTION OF THE CITY OF MAPLE VALLEY,  
WASHINGTON, AUTHORIZING ACCEPTANCE GRANT  
MONEY FOR THE DEVELOPMENT OF A DISC GOLF COURSE  
PROJECT FROM KING COUNTY YOUTH SPORTS FACILITY  
GRANT**

WHEREAS, the City of Maple Valley City Council considers it within the best public interest to develop a disc golf course on the 8.7 acre Peninsula Property within Lake Wilderness Park; and

WHEREAS, the City of Maple Valley City Council has approved a comprehensive plan that includes this project area; and

WHEREAS, under the provisions of the King County Youth Sports Facility Grant in aiding financing of the disc golf course project; and

WHEREAS, the disc golf project is fully described within the King County Youth Sports Facility Grant;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, AS FOLLOWS:

Section 1. Authorization: The City Manager is hereby authorized to accept the King County Youth Sports Facility Grant agreement, and to make the following acknowledgements and certifications on behalf of the City:

1. Any funding assistance received must be used for implementation of the project referenced above;
2. The City of Maple Valley hereby certifies that its share of project funding is committed and will be derived from appropriations and/or cash;
3. The City of Maple Valley, through its City Manager, acknowledges that the City is responsible for supporting all non-cash commitments to this project should they not materialize;
4. The City is aware that the Grant, will be paid on a reimbursement basis. This means the City may only request payment after eligible and allowable costs have already been paid and remitted to its vendors.
5. The City Manager acknowledges that any property acquired or facility developed with financial aid from the Youth Sport Facility Grant (YSFG) must be placed in use for the funded purpose and be retained in such use in perpetuity unless otherwise provided and agreed to by the City and YSFG.
6. This resolution becomes part of a formal acceptance to the King County Youth Sports Facility Grant; and
7. The City Council provided appropriate opportunity for public comment on this project.

The grant agreement shall be filed with the City Clerk and identified with the Clerk's Receiving Number \_\_\_\_\_.
