

CITY OF MAPLE VALLEY INVITATION TO BID

Sealed bids will be received by the City of Maple Valley, Washington, at the reception desk located at 22017 SE Wax Road, Suite 200, Maple Valley Washington until 1:00 p.m., May 18, 2018. Bids will then be opened and publicly read at 1:30 p.m. on that same day at City Hall, 22017 SE Wax Road, Suite 200, Maple Valley, WA 98038, for:

SE 256TH STREET REALIGNMENT PROJECT

Note: The Proposed Subcontractors list must be submitted with the bid package within the deadline listed above, and will NOT be accepted after that deadline.

The Work to be performed within **70** working days from the date of Notice to Proceed consists of furnishing all materials, equipment, tools, labor, and other work or items incidental thereto for:

Construction of a fish passable split box culvert structure under SE 256th St for Jenkins Creek and realigning the roadway intersection of SE 256th St and Witte Road SE. Work also includes stream restoration and wall work for Jenkins creek along with franchise utility relocation construction on Witte Road. General scope of work includes the following: Culvert Construction, Stream Diversion, Stream Grading and Restoration, CMU block wall construction, Landscape Restoration, Paving, Grading, Pavement Marking, Seeding and Mulching, Utility and Culvert Shoring, Utility Trench Excavation and Conduit Installation, and Work Zone Traffic Control.

The engineer's estimate is between \$550,000 and \$745,000.

All bid proposals shall be accompanied by a bid proposal deposit in cash, certified check, cashier's check, or surety bond in an amount equal to five percent (5%) of the total amount of such bid proposal, including sales tax. Should the successful bidder fail to enter into such contract and furnish satisfactory payment and performance bonds within the time stated in the Contract Documents, the bid proposal deposit shall be forfeited to the City of Maple Valley.

Bidders are encouraged to "Register as a Bidder", in order to receive automatic email notification of future addenda and to be placed on the "Bidders List". Bidders are not to contact the City of Maple Valley or the Engineer to obtain bidding documents. Starting April 30, 2018, informational copies of Plans and Contract Provisions will be available on file for inspection at the King County Library located at 21844 SE 248th Street, Maple Valley, Washington. The library's hours are 10am-9pm M-Th, 10am-6pm F, 10am-5pm Sat, 1pm-5pm Sun.

Small business and minority-owned businesses are encouraged to submit bids. No minimum level of participation for small businesses has been established for purpose of this solicitation.

This Invitation to Bid may be canceled at the discretion of the City. If the invitation is canceled, notice of cancellation will be sent to all parties who have registered on the Plan-holders list at Builders Exchange. The notice will briefly state the reason for cancellation.

The City reserves the right to reject any and all bids, to waive any informality in the bidding, and to make the award to the lowest responsible bidder as determined by the City.
