RESOLUTION NO. R-17-1144

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, AUTHORIZING EXECUTION OF AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF MAPLE VALLEY AND UNITED STATES DEPARTMENT OF AGRICULTURE ANIMAL AND PLANT HEALTH INSPECTION SERVICE WILDLIFE SERVICES FOR THE MANAGEMENT OF CANADA GEESE AND OTHER WILDLIFE.

WHEREAS, RCW 39.34.030 authorizes an agreement for joint or cooperative action by a public agency upon appropriate legislative action by the governing body of each agency prior to entry into such agreement; and

WHEREAS, the City of Maple Valley incorporated on August 31, 1997; and

WHEREAS, pursuant to state law, Maple Valley is responsible for managing activities to Canada geese and other nuisance wildlife in the City of Maple Valley in order to reduce human health and safety threats and associated maintenance problems; and

WHEREAS, Maple Valley does not have qualified personnel to manage nuisance wildlife; and

WHEREAS, United States Department of Agriculture (APHIS-WS) manages activities to manage Canada geese and other nuisance wildlife in order to reduce human health and safety threats and associated maintenance problems; and

WHEREAS, United States Department of Agriculture (APHIS-WS) can provide the City of Maple Valley, management services to manage Canada geese and other nuisance wildlife pursuant to the terms of this Agreement;

WHEREAS, the City Council of Maple Valley desires to enter into a interlocal agreement with the United States Department of Agriculture Animal and Plant Health Inspection Service Wildlife Services (APHIS-WS);

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, DO RESOLVE AS FOLLOWS:

Section 1. Authorization. The City Manager is hereby authorized to execute the Interlocal Agreement between the City of Maple Valley and United States Department of Agriculture (APHIS-WS) relating to the provision of wildlife manage services as attached hereto. A copy of the Interlocal Agreement has been filed with the City Clerk and identified with Clerk's Receiving No. 2683.
