Maple Valley Businesses Receive Grant Funding

Maple Valley, Wash. – August 4, 2020 – The City of Maple Valley is pleased to announce that 43 Maple Valley businesses have received grant funding through either the Governor’s Working Washington Small Business Emergency Grant Fund or through the U.S. Treasury Department’s Cares Act Economic Resiliency Grant Program (CARES Act). The CARES Act funding was provided to the City of Maple Valley by the Washington State Department of Commerce to utilize in ways that best help the City recover from the pandemic and to strengthen the economy.

Because the City of Maple Valley is committed to its small business community to help them recover successfully from the impacts of COVID-19, the City’s Economic Development Commission reviewed the criteria established by the U.S Treasury Department and the Washington State Department of Commerce and made a recommendation to the City Council that funding be provided to qualified small businesses who exhibited financial harm during this pandemic. The City Council authorized the use of a portion of these funds for business recovery purposes and a Grant Review Committee was formed to review applications and award funding.
