SCHOLARSHIP APPLICATION**

It is the hope of the City of Maple Valley Parks & Recreation Department to make recreation opportunities available to all interested people, regardless of income. To that end, residents of the Maple Valley area may qualify for scholarships if their annual incomes are less than those listed below. The City of Maple Valley reserves the right to utilize a lottery system for the distribution of scholarships in the case whereby there are more applicants than funds available.

Scholarships will be available to pay 100%, 75%, and 50% of the program fees. If an individual receives a partial scholarship, they will be required to pay the difference in the program fees prior to participation. Special arrangements may be made for deferred payment.

To apply, complete the application and return it to the Maple Valley Parks and Recreation Department. An application may be picked up at the Lake Wilderness Lodge or City Hall front desk or one may be mailed to you by calling (425) 432-9953.

**Scholarship Eligibility.** Applicants must submit their most recent W-2 Earnings Statement AND proof of qualification for or participation in one of the following:

1. Free or reduced school lunch program
2. Preschool age children participating in the Head Start program
3. Government subsidized daycare
4. Receiving DSHS services for the applicant or food stamps for the family

Once the application and proof of eligibility is received, reviewed and approved, a Parks & Recreation award letter will be mailed to you. Please return the award letter when registering for a program.
