**RESOLUTION NO. R-12-879**

**A RESOLUTION OF THE CITY OF MAPLE VALLEY, WASHINGTON,  
AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENT  
NO. 7 TO THE PROFESSIONAL SERVICES AGREEMENT, C-08-575,  
WITH KPG, INC. FOR ENGINEERING CONSULTING SERVICES**

WHEREAS, on July 27, 2007, the City of Maple Valley received a grant in the amount of \$3,000,000.00 from the Washington State Department of Community, Trade, and Economic Development (CTED) for designing streets on, near, and around the City's "Legacy Site;" and

WHEREAS, on February 19, 2008, the City Council of the City of Maple Valley approved Resolution R-08-568 authorizing a professional services agreement with KPG, Inc., to provide engineering design services for the Maple Valley Highway, from SE 264<sup>th</sup> Street to SE 255<sup>th</sup> Street; and SE 260<sup>th</sup> Street, from SR-169 to Lake Wilderness Trail project; and a street connecting Maple Valley Highway to SE 260<sup>th</sup> Street, through the Legacy site; said agreement subsequently being executed and assigned Contract No. C-08-575; and

WHEREAS, the project was revised through legislative action by the Council into Project T31a and T31b and the Scope of Services for Contract No. C-08-575 currently includes engineering design services for Project T31a; and

WHEREAS, the City Council of the City of Maple Valley desires to amend the project scope, increase the compensation; and amend the duration of Contract C-08-575 consistent with the scope of Project T31a;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON RESOLVES AS FOLLOWS:**

Authorization. The City Manager is hereby authorized and directed to execute on behalf of the City of Maple Valley Amendment No. 7 to the professional services agreement with KPG, Inc., for engineering consulting services to: amend the scope of work as shown in Exhibit A to the Amendment No. 7; to provide for an increase in compensation of \$98,568.71, for a total not-to-exceed amount of \$1,289,109.00; and to amend the duration of the agreement. A copy of Amendment No. 7 has been filed with the City Clerk and identified with Clerk's Receiving Number \_\_\_\_\_.
