RESOLUTION NO. R-12-870

A RESOLUTION OF THE CITY OF MAPLE VALLEY, WASHINGTON, AUTHORIZING THE CITY MANAGER TO EXECUTE JOINT UTILITY TRENCH AGREEMENTS WITH ELECTRIC LIGHTWAVE LLC, CENTURY LINK, AND COMCAST FOR THE RELOCATION OF AND UNDERGROUND PLACEMENT OF UTILITY DISTRIBUTION LINES IN CONJUNCTION WITH THE SR 169 MAPLE VALLEY ROADWAY IMPROVEMENTS PROJECT (T-7 & T-31)

WHEREAS, the City Council has determined to construct a road improvement, known as the SR 169 Maple Valley Roadway Improvements Project (T-7 & T-31), and has appropriated money for the project in the 2012 Capital Improvement Program; and;

WHEREAS, the City Council has adopted policies promoting health, safety and welfare of its citizens by causing aerial utility lines to be placed underground and relocated as required for roadway construction projects; and

WHEREAS, the City of Maple Valley desires that the improvements to the Maple Valley roadway include undergrounding of utilities; and

WHEREAS, the utility providers required to underground their utilities have prepared a design for each of their distribution systems which the City has reviewed, found acceptable, and included in the SR 169 Maple Valley Roadway Improvements Project (T-7 & T-31) construction documents, where applicable; and

WHEREAS, it is necessary for the City to enter into agreements with utility providers that provide for such items as trenching, installation, energizing and assigning cost allocation between the utility providers and the City; and

WHEREAS, the proposed agreements provide for the reimbursement of certain costs to the City by utility providers for work to be performed by the City and relating to relocation of said utilities;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, AS FOLLOWS:

Authorization: The City Manager is hereby authorized to execute the joint utility agreements with Electric Lightwave LLC, CenturyLink, and Comcast. A copy of the agreements shall be filed with the City Clerk and identified with Clerk's Receiving Number(s)_____.
