RESOLUTION NO. R-13-913

A RESOLUTION OF THE CITY OF MAPLE VALLEY, WASHINGTON, AUTHORIZING THE CITY MANAGER TO EXECUTE A PUBLIC WORKS CONSTRUCTION CONTRACT WITH WELWEST CONSTRUCTION, INC., FOR CONSTRUCTION SERVICES ON S-14 LAKE LUCERNE OUTLET CULVERT REPLACEMENT AND HABITAT ENHANCEMENTS PROJECT.

WHEREAS, the City Council of the City of Maple Valley desires to construct the improvements for S-14 Lake Lucerne Outlet Culvert Replacement and Habitat enhancements Project; and

WHEREAS, the City solicited Invitations to Bid from individual construction firms qualified to complete Project S – 14; and

WHEREAS, the City received nine proposals in response to the City's Invitation to Bid; and

WHEREAS, Welwest Construction, Inc. was the lowest responsible bidder; and

WHEREAS, the City has reviewed bid documents submitted by Welwest Construction, Inc., and has found them to be substantially complete; and

WHEREAS, the City is requesting that the City Manager be granted the authority to execute a Public Works Contract with Welwest Construction, Inc., to perform the construction services for S-14 Lake Lucerne Outlet Culvert Replacement and Habitat Enhancement Project in the total bid amount of \$91,930.99;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, DO RESOLVE AS FOLLOWS:

Section 1. Authorization. The City Manager is hereby authorized to execute a Public Works Contract with Welwest Construction, Inc., to perform the Construction Services for S-14 Lake Lucerne Outlet Culvert Replacement and Habitat Enhancement Project in the total bid amount of \$91,930.99 plus a 10% contingency fund. A copy of the Public Works Contract has been filed with the City Clerk and identified with Clerk's Receiving No. _____.

Section 2. Contingency. The City Council hereby acknowledges the contract amounts for the S-14 Lake Lucerne Outlet Culvert Replacement and Habitat Enhancement Project are subject to the City's established contingency policy allowances. This allowance shall be a 10% contingency which is equivalent to \$9,193.10.
