RESOLUTION NO. R-13-936

A RESOLUTION OF THE CITY OF MAPLE VALLEY, WASHINGTON, AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF MAPLE VALLEY AND WASHINGTON STATE DEPARTMENT OF ECOLOGY FOR PROVISION OF 2013 THROUGH JUNE 30, 2015 COORDINATED PREVENTION GRANT AGREEMENT.

WHEREAS, Washington State Department of Ecology (Ecology) Coordinated Prevention Grant funds are allocated to agencies based on population as reported by Washington State Office of Financial Management; and

WHEREAS, in July 2011 Ecology sent notice to agency recipients of Coordinated Prevention Grants informing them that Ecology would no longer administer grants to agencies with grant funding allotments under \$30,000 and recommended that agencies partner with one another to combine agency grant allotments that meet or exceeded the \$30,000 threshold; and

WHEREAS, Maple Valley staff applied for and was awarded the 2013-2015 Coordinated Prevention Grant on behalf of the cities of Maple Valley, Covington, and Black Diamond; and

WHEREAS, the Coordinated Prevention Grant funds, combined with grant funds from other grantors, allow the city to offer special recycling collection events to residents and businesses to provide an avenue to recycle items typically not collected in residential or commercial collection programs, and;

WHEREAS, the special recycling collection program diverts resources from entering the Cedar Hills Regional Landfill and is consistent with the King County Solid Waste Comprehensive Plan; and

WHEREAS, the City desires to continue to offer these popular recycling collection events to residents and businesses;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, AS FOLLOWS:

- A. The City Manager is authorized and directed to execute the Washington State Department of finalized Ecology Coordinated Prevention Grant Agreement for provision of residential and business recycling events for 2013 through 2015
- B. A copy of the agreement shall be filed with the City Clerk and identified with Clerk's Receiving No. _____.
