**RESOLUTION NO. R-14-973**

**A RESOLUTION OF THE CITY OF MAPLE VALLEY, WASHINGTON,  
AUTHORIZING THE CITY MANAGER TO EXECUTE AN  
AGREEMENT WITH RECOLOGY CLEANSCAPES, INC., FOR  
COMPREHENSIVE GARBAGE, RECYCLABLES AND COMPOSTABLE  
COLLECTION, DISPOSAL, AND MARKETING**

WHEREAS, the City of Maple Valley incorporated in 1997 and subsequently granted a conversion franchise to Rabanco Ltd., D.B.A, Kent-Meridian Disposal, which expired August 31, 2007; and

WHEREAS, in 2007 the City desired to contract for comprehensive garbage, recyclables and organics collection when the Kent-Meridian Disposal agreement expired and directed staff to published a request for proposal in January 2007; and

WHEREAS, the City received proposals in 2007 from CleanScapes, Kent-Meridian Disposal, and Waste Management and identified Waste Management as the top ranked proponent; and

WHEREAS, In May 2007 Maple Valley Council adopted Resolution R-07-537 authorizing the City Manager to enter into a seven year Agreement with Waste Management that is set to expire on August 31, 2014; and

WHEREAS, in March 2013 staff sought and received direction from Maple Valley City Council to exercise the competitive process to obtain proposals from haulers for a new Solid Waste Collection service contract with market-tested rates; and

WHEREAS, staff published a request for proposal on October 1, 2013 with a submittal due date of December 3, 2013; and

WHEREAS, the City received proposals from Recology CleanScapes, Republic Services and Waste Management; and

WHEREAS, Recology CleanScapes, Inc., was unanimously selected as the top ranking finalist by a 5-member evaluation team consisting of City staff; and

WHEREAS, Recology CleanScapes, Inc., offer includes reduced rates for all service sectors and enhanced services; and

WHEREAS, the City and Recology CleanScapes, Inc. have negotiated an agreement to the mutual satisfaction of both parties:

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE  
CITY OF MAPLE VALLEY, WASHINGTON, AS FOLLOWS:**

Authorization. The City Manager is hereby authorized and directed to execute on behalf of the City of Maple Valley an Agreement with Recology CleanScapes Inc. for comprehensive garbage, recyclables and organics collection disposal and marketing services that shall commence September 1, 2014 and terminate on August 31, 2021 with two two-year extension options that may be implemented at the City's sole discretion. A copy of the Agreement will be filed with the City Clerk and identified with Clerk's Receiving No.\_\_\_\_\_.
