WHEREAS, the cities of Maple Valley and Enumclaw entered into a Jail Services Agreement May 28, 1998; and

WHEREAS, the parties have negotiated an addendum to the agreement to provide for a new section, Reservation of Facilities, to guarantee the City of Maple Valley space for at least two prisoners per day; and

WHEREAS, this agreement is entered into under the Interlocal Cooperation Act, RCW 39.34; NOW, THEREFORE
