**RESOLUTION NO. R-15-1062**

**A RESOLUTION OF THE CITY OF MAPLE VALLEY, WASHINGTON, AUTHORIZING THE CITY MANAGER TO EXECUTE STREET LIGHTING AUTHORIZATION LETTER WITH PUGET SOUND ENERGY, INC./INTOLIGHT TO INSTALL STREET LIGHTS AS REQUIRED FOR THE TRANSPORTATION IMPROVEMENT PROJECT T38**

WHEREAS, the City of Maple budgeted for the construction of transportation project T38 on 216<sup>th</sup> Avenue SE that include the installation of new street lights; and

WHEREAS, pursuant to the City's franchise agreement with Puget Sound Energy, Inc., the City may request Puget Sound Energy, Inc. to install new street lights as required on the City's transportation improvement projects; and

WHEREAS, pursuant to the franchise agreement, the City has requested Puget Sound Energy, Inc./Intolight to install the street lights system on transportation project T38;

WHEREAS, Puget Sound Energy, Inc./Intolight has agreed to install street light systems on transportation project T38;

WHEREAS, the City Council approved the Resolution R-15-1018 on January 26, 2015 authorizing the City Manager to enter into an agreement with Puget Sound Energy, Inc./Intolight for the amount of \$253,730.10;

WHEREAS, Bonneville Power Association has height restrictions for streetlights installed within their easement to nearly half the height of what was originally planned;

WHEREAS, the reduced streetlight pole heights requires the installation of three addition streetlights;

WHEREAS, the additional streetlights will increase the cost by \$8,958.30;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, DO RESOLVE AS FOLLOWS:**

Section 1. Authorization. The City Council hereby authorizes the City Manager to execute a revised Street Lighting Authorization Letter with Puget Sound Energy, Inc./Intolight for the installation of a street light system on transportation project T38 in the amount of \$262,688.40. A copy of the Street Light Authorization Letter have been filed with the City Clerk and identified with Clerk's Receiving No. \_\_\_\_\_.
